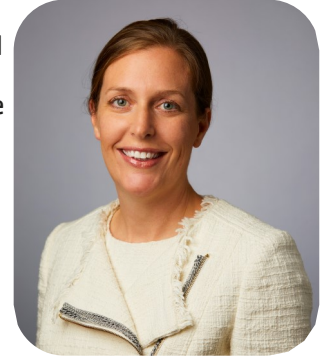

MESSAGE FROM KRISTEN

Dear YMCA Friends and Colleagues,

It has been an honor to serve as the board chief volunteer officer for the past year and I am thankful to have had the opportunity. This last year has seen a lot of exciting changes and I am glad to be a part of it. It is always a blessing to see the lives that we touch at our YMCA, by providing programs that both align with our mission and meet the needs of the community. Here are a few of the major accomplishments from 2022:



- In March of 2022, we held a ribbon cutting for the first part of our capital improvements, the Family Changing Locker Rooms. This expansion has given families a place to comfortably get ready to use the pool and other areas of our facility.
- We partnered with the Decatur County Memorial Hospital and the Greensburg Daily News for an Easter Egg Drive Thru in April 2022 where we handed out 384 meals to the children of our community 18 years old and younger.
- In June, at Decatur County we held our 23rd Annual golf outing. We were excited to see Shelby County follow the tradition as they held their first Annual Golf Outing on July 16 of 2022.
- The Shelby County YMCA hosted the 8 week "Summer of Growth" program sponsored by Edward Jones where we had over 180 participants take part in a different theme each week from Vacation Bible School, to arts and crafts, to sports and fitness.
- On July 26, Shelby County celebrated their first year anniversary in collaboration with MHP, with a ribbon cutting, an all-day open house with activities for the community, concluding with a live band in the evening. We had over 1,900 membership units to celebrate that day, a great achievement for our new facility. Today we have over 2,700 membership units.
- On August 21, 2022 we saw our capital campaign come to a successful conclusion with the ribbon cutting for the expansion which included the Indoor Playground, the expanded wellness center, the family changing locker rooms, and additional conference space. In addition, the expansion included the 3000sq ft dedicated space for our collaboration with the Decatur County Memorial Hospital where they offer wellness programs, massages, and post rehab services.
- We hosted our Annual "Halloween Carnival" in 2022 and with the addition of the indoor playground we saw our attendance soar to over 300 people that came put to enjoy the festivities.
- Our 21st Century Program was once again run out of Greensburg elementary, where we had 61 participants. This program continues to assist children in making improvements in their math and reading skills to a C or better for over 92% of participants, exceeding the target goal of 70%.
- As of December 2022, we had a combined 4,436 membership units between the 2 branches, 1,954 from Decatur County and 2,482 from Shelby County.
- We had a booth at the Decatur County Memorial Hospital's Holiday Lane Event where there were over 750 participants.
- We continue to support those individuals and families in need, allocating over \$94,000 in financial aid to 242 participants allowing them to utilize our facility and programs such as, child care, youth programs and memberships.
- Our Preschool Program remains a Paths to Quality, Level 3, one of only a few in the area. Paths to Quality is Indiana's voluntary quality rating and improvement system that includes four levels. We served over 107 students in our preschool program in 2022.

2022 was a very successful year where we saw the results of our work come to fruition. I see the many great opportunities for growth for us as an association and look forward to all the new things we can achieve at both branches. Thank you for your continued support of the YMCA.

21st CENTURY

Our 21st Century Program allows qualified children additional care after school which includes recreation time, tutoring and enrichment, while being under the supervision of trained Y staff. Students are also fed a full, well-balanced meal through our year-round feeding program. In 2022, our program served 61 students. Slightly over 92% of the 1st through 5th grade regular participants achieved a C or better in reading from the Fall to Spring semester. Over 97% of the 1st through 5th grade participants achieved a C or better in Math from the Fall to Spring semester. Both measurements exceeded the target goal of 70%.

PRESCHOOL/AFTERSCHOOL/CAMP

Our entire child care department is devoted to assisting our community's children in the areas of growth, learning and development, centered in a loving, Christian atmosphere while teaching them educational components and structuring the process based on our core values of honesty, caring, respect and responsibility.

- Our Preschool is a licensed program and has achieved Paths to Quality Level 3 status, out of 4, which we achieved in early 2022.
- In 2022, because of the Annual Campaign, 33 children received child care.

YOUTH DEVELOPMENT

INDIANA YOUTH AND GOVERNMENT (INYaG)

The Indiana YMCA Youth and Government (INYaG) program provides a fun and unique opportunity for youth in grades 7 through 12 to connect with their peers from around the state while learning how to effect change on social and political issues of personal importance to them. Through the program, youth first engage in local delegation meetings where they firm up their understanding of how their governments work. Then, they learn how to make their governments work for them. Along the way, they learn how to effectively investigate and articulate their concerns while being part of decision-making processes. Local activities lead to a day-long regional leadership conference during the fall and a three-day statewide model government conference in March. During the statewide conference, students take over the Indiana Statehouse to apply what they learned during their delegation meetings. The program also creates avenues for youth to apply their developed skills and understandings through real-life advocacy opportunities and national civic engagement opportunities that connect them to their peers around the country. INYaG is ideal for any students who want to improve their abilities to interact with adults and other youth, understand how to influence governments for effective and peaceful resolution, appreciate the diversity of viewpoints on public issues, demonstrate citizenship responsibilities and leadership roles essential for more accommodating communities, and embrace respect for ideas, beliefs, and the positions of others. During the 2023 conference, our delegation had 5 delegates, with one

delegate, Karigan Acton, serving as the Lieutenant Governor. This year's group also included Tyler Biddinger, Brenley Jameson, Charlie Stauffacher, and Tyler Williams.

SAFETY AROUND WATER

Safety Around Water has been introduced in more than 2,200 pools across the United States in an effort to teach basic swimming skills, personal safety and safe water principles to children. While drowning is a concern for all children – it's the second leading cause of unintentional injury-related death for children ages one to 14 years old. Thanks to support from KB foods and a grant from YMCA of the USA, we were able to enroll 93 participants in this program between Decatur County and Shelby County!

YOUTH PROGRAMMING

We are able to offer a variety of classes and leagues geared specifically for our youth in a quest to come alongside parents and help teach basic skills while encouraging positive behavior.

- 16 additional children participated in youth sports with financial assistance from our Annual Campaign drive.

HEALTHY KIDS DAY

Every year we host a Healthy Kids Day at the YMCA. Healthy Kids Day is a nationally celebrated YMCA event, that concentrates on the belief that children who possess knowledge of healthy habits will grow into strong adults. The YMCA offers a variety of programs to help children and families achieve this goal. Together, we can provide the community with the ability to develop healthy lifestyles. As part of their Inaugural Healthy Kids Day, the Shelby County YMCA had the Pacers mascot, Boomer as part of their festivities!



HEALTHY LIVING

EVIDENCE-BASED HEALTH INTERVENTIONS

The YMCA is focused on doing whatever it takes to help reduce the onset of chronic diseases in our community. We strive to increase the overall health and well-being of everyone who walks through our doors. We currently offer many Evidence-Based Health Intervention Programs at our facility like the Blood Pressure Self-Monitoring Program and Diabetes Prevention Program and Delay the Disease: Parkinson's Exercise Program. This program is designed for people living with Parkinson's Disease to help empower those living with the disease by optimizing their physical function and helping to delay the progression of their symptoms.

Delay the Disease: Parkinson's Exercise Program

What happens in class?

- Flexibility – utilizing yoga and dynamic stretching
- Coordination – utilizing stability balls, medicine balls, agility drills, dance, ladder walking and boxing
- Respiratory – yells, cheers and various voice drills
- Cardiovascular – walking, marching, cycling, boxing, rowing
- Balance – standing on one foot, side stepping, tandem standing and walking
- Strength training – using weighted medicine balls, dumbbells, resistance tubes and bodyweight

Changes participants have noticed:

- Improved posture & strength
- Improved balance & walking ability
- Help preventing falls & restore general functional ability
- Improved cardiovascular health
- May also see improvement in memory, sleep, mental health and overall quality of life.

Statistics from class:

- Eleven people have been enrolled in this program, but only three people have completed at least a full 12-weeks of the class program to date.
- The three participants that have completed at least 12-weeks of the program decreased their Sit to Stand Score by 50%, decreasing the time it took to complete Five Sit to Stands by 1/2 at the end of the 12-week program.
- Both participants were able to balance on one leg for 30 seconds, which was 10 seconds longer than when they started the program.
- Both participants also decreased their Timed Up and Go score by 3 seconds from when they started the class.

Blood Pressure Self-Monitoring Program

The simple process of checking and recording your blood pressure at least twice a month over a period of four months has been shown to lower blood pressure in many people with high blood pressure. The YMCA's Blood Pressure Self-Monitoring Program helps participants:

Reduce their blood pressure by identifying patterns and trends on which to take action

- **Better manage their blood pressure over time**
- **Increase their awareness of triggers that elevate blood pressure**
- **Improve their knowledge of heart-healthy eating habits**
- **Enrich communication with their health care provider by sharing self-monitoring results**

Nutritional Seminars are also offered one time a month and highlight how food is related to blood pressure management and will provide knowledge and skills to make heart-healthy choices. Seminar topics include reducing sodium intake and heart healthy eating.

During 2022, we served over 20 participants for our Blood Pressure-Self Monitoring Program at the Decatur County Family YMCA location. Due to a grant we received from Y-USA, we were able to expand this program to our Shelby County location getting five new Healthy Heart Ambassadors certified to offer this program starting in 2023.

CAPITAL CAMPAIGN RECAP

We started of 2022 by completing the new Family Changing Locker Rooms for the pool area at the end of January 2022 and held a Ribbon Cutting on Tuesday, March 29, 2022, opening them for use to the members. On August 21, 2022, we had our Grand Opening Celebration with ribbon cutting for the new addition, which included the Indoor Playground, the expanded Wellness Center, additional Family Changing Locker Rooms and the Decatur County Memorial Hospital's 3000 square foot of dedicated space for education, wellness, and post-rehabilitation programs called HealthConnect.



ANNUAL YMCA GOLF CLASSIC

Our 23rd Annual YMCA Golf Classic was held on Thursday, June 2, 2022 at the Greensburg Country Club to help raise money for our Annual Campaign. This year, we had 16 teams that participated along with 45 hole sponsors and more than 30 silent auction items. Altogether \$9,752.07 was raised to help families participate in Y programming that may not otherwise be able to participate. Thank you again to all our participants and sponsors for helping us have such a wonderful event this year!

TREE CITY ROLLING TOUR

June 25, 2022 marked our 13th Annual Tree City Rolling Tour & Century Ride, which starts and ends at our beautiful Courthouse. We hosted 180 riders this year, and everyone enjoyed a beautiful ride. Depending on the distance chosen, riders were able to ride around beautiful Lake Santee or ride through the scenic Enochsburg and Hamburg areas some riders even went out to explore Westport, like our 100 mile bike riders did, leaving before 7:00 am on race morning! Refreshments were placed every 8 to 15 miles along each route for riders to get off of their bikes, stretch, use rest rooms if needed and grab a quick snack. After finishing up their rides, riders were welcomed back to the Courthouse Square for a wonderful meal and live music, provided by the "Hippy Fingers" band. All the riders complimented the food, music, wonderful sag (refreshment) stops, and friendly volunteers.



CORPORATE CHALLENGE

August 2022 brought our 33rd Annual Corporate Challenge event to the YMCA. This year Decatur County Memorial Hospital, Delta Faucet, First Financial Bank, Honda- Civic, Honda- CRV, Valeo and the YMCA all vied for the coveted Corporate Challenge Crown over the course of four days August 8th, 9th, 11th and 13th. The events ranged in scale from Euchre and Bowling to Trivia and Punt, Pass Kick events with Delta Faucet taking home the top prize!

TREE CITY RUN

The Decatur County Family YMCA held its 45th Annual Tree City Run on Saturday, November 19, 2022, which included the options of a 5K run or walk or a 10K run. We did have 31 runners and walkers join us on a frigid, cold, snowy November Day! We continued our new route which allowed all participants to SEE the TREE!

1ST ANNUAL YMCA GOLF OUTING

Shelby County held its 1st Annual Golf Outing on Saturday, July 16, 2022 to help raise money to expand the Wellness Center offerings. This year, we had 27 participants join us at the Blue Bear Golf course and had a great day!

1 YEAR ANNIVERSARY and RIBBON CUTTING



Shelby County held a ribbon cutting ceremony with MHP in partnership with the Shelbyville Chamber of Commerce on its 1st Anniversary, July 26, 2022. They celebrated with an open house, food, prizes, games and capped it off with a live band in the evening. It was exciting to note we had over 1,900 units join in our first year!

SUMMER OF GROWTH

Shelby County had its first Summer of Growth Program sponsored by Edward Jones. The program had over 65 youth participants with 182 registrations. Over the course of the 8 weeks, children were able to participate in the following activities: Vacation Bible School, Cooking and Sewing, Swim and Strength, Multi-sports, Theatre, STEM, and music, arts and crafts. It was a great time for all the kids and for the staff that participated!

ACADEMIC REINFORCEMENT PROGRAM

Shelby County held an academic reinforcement program through the summer to help prevent a loss of learning over the summer months. We were excited to have 64 participants in this program.

BLOOD PRESSURE SELF-MONITORING PROGRAM

Due to a grant we received from Y-USA, Shelby County started this program in August of 2022. They have five new Healthy Heart Ambassadors certified to offer this program.

FAMILY FUN RUN

The Shelby Co. YMCA partnered with MHP on a 5k Run/Walk, the "Healing Hustle." The Y offered a "Family Fun Run" which had 24 participants including parents and kids.

EXPANDED WELLNESS CENTER

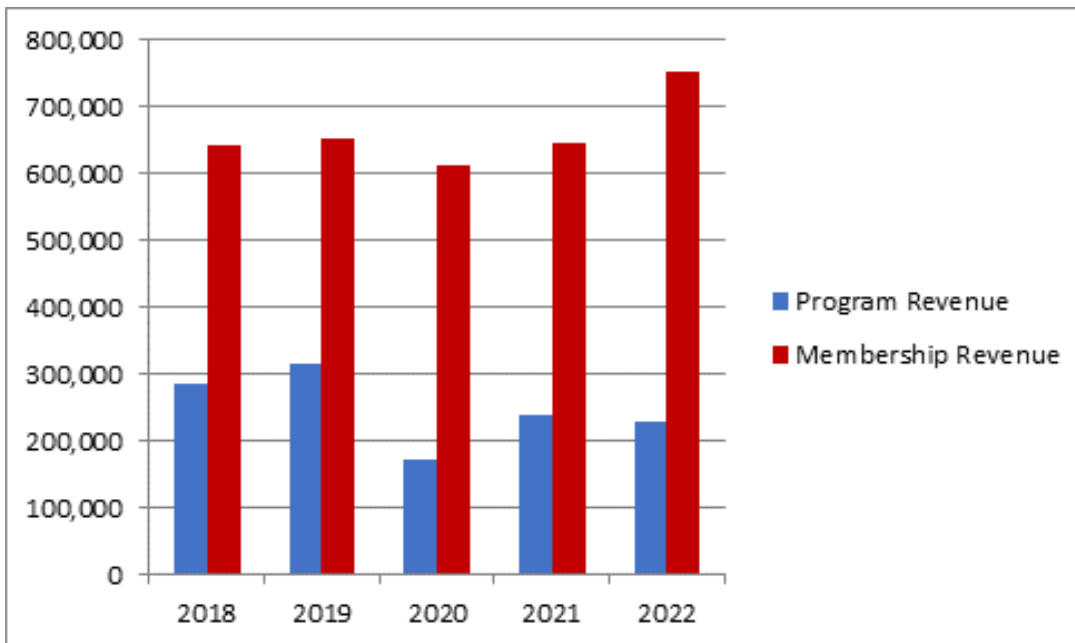
We were excited to be able to expand the limited free weight area by converting unused space into additional lifting space for members to use while working out.

MEMBERSHIP

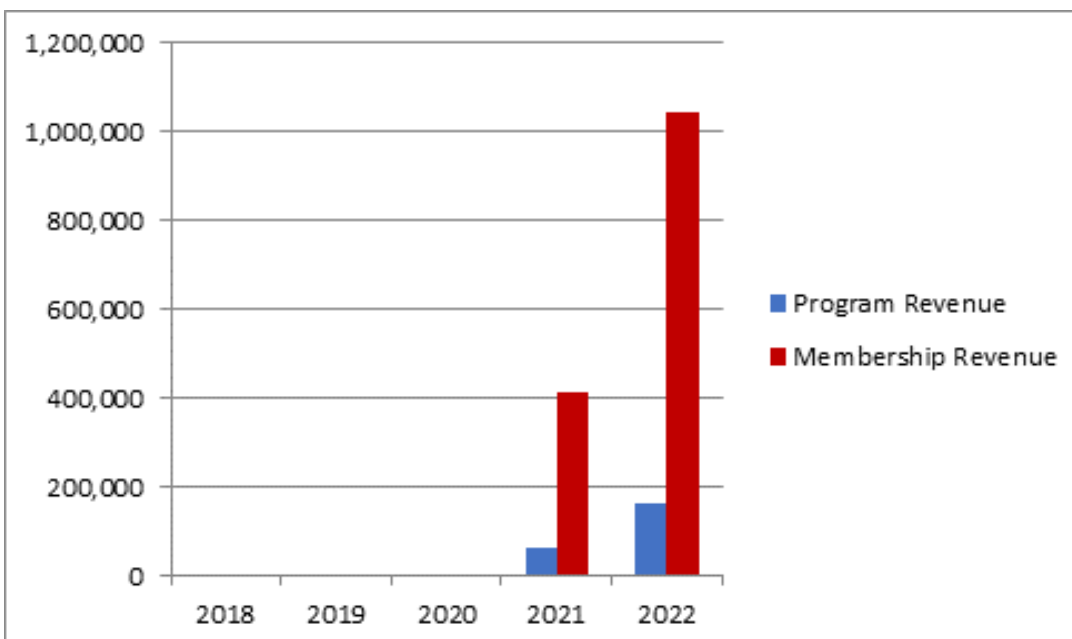
It was exciting to end the year with 2,482 membership units, an increase in 367 units from the previous year, which was a 17% increase! We look forward to welcoming more members in 2023!

Decatur County Family YMCA Membership & Program Revenue 5 year Comparison

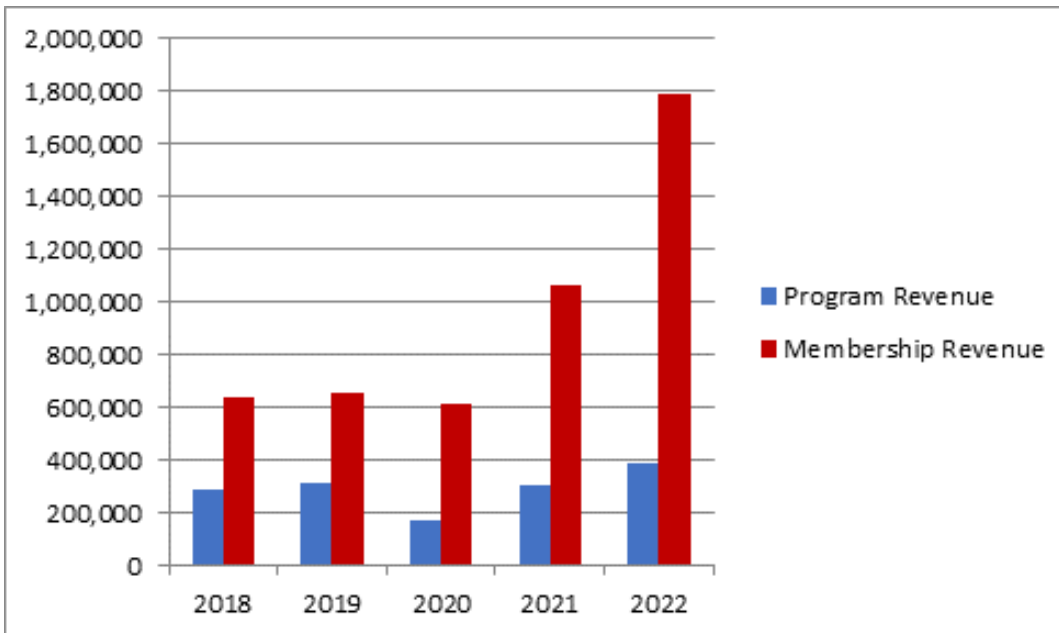


Shelby County YMCA Membership & Program Revenue 2 year Comparison

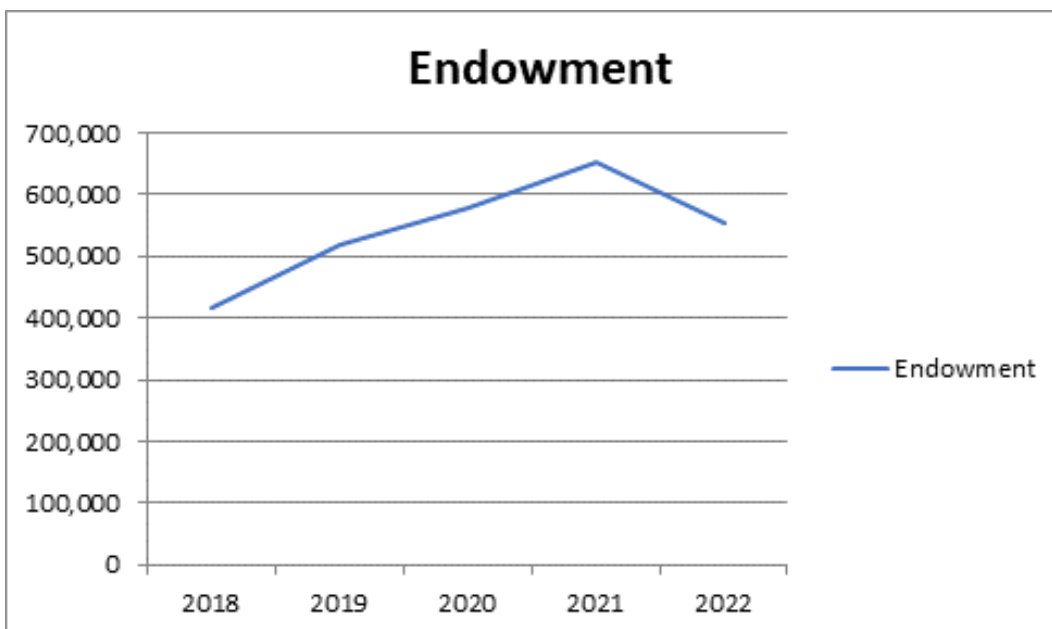

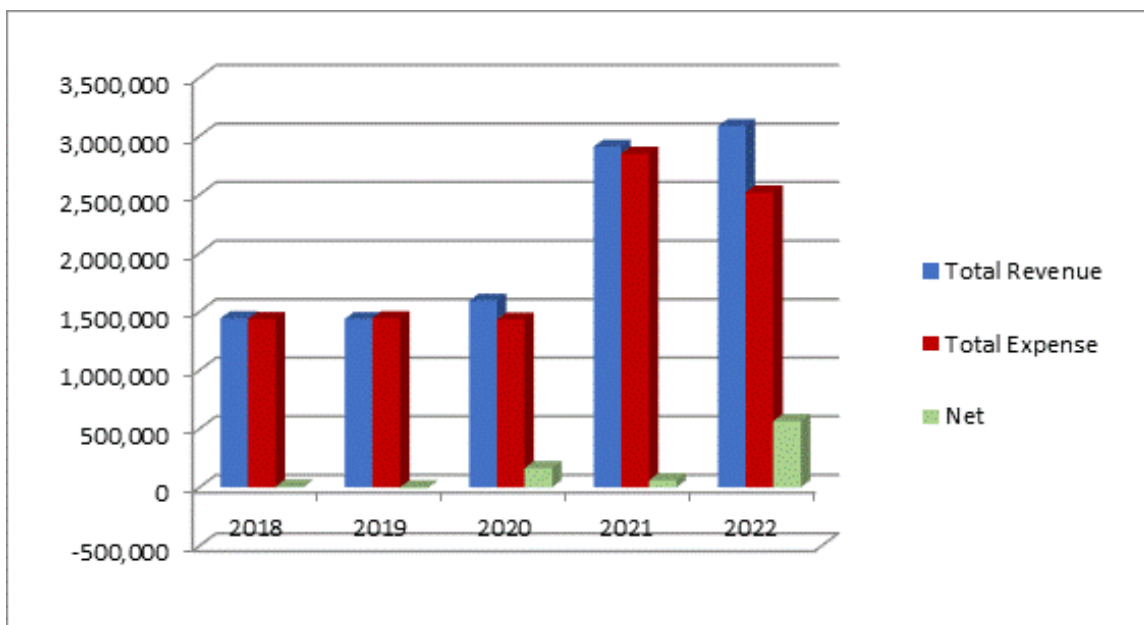
